What Constitutes Ragging


- Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing treating or handling with rudeness a fresher or any other student
- Indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student
- Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating sense of shame, or torment of embarrassment so as to adversely affect the physique or psyche of such fresher or any other student
- Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by student

Punishment(s) in the event of Ragging



RAGGING

- **Cancellation of admission**
- **Suspension / Expulsion from the hostel**
- **Suspension from attending classes and academic privileges**
- Withholding / withdrawing scholarship / fellowship and other benefits
- **Debarring from appearing in any test / examination or other evaluation** process
- Withholding results
- **Debarring from representing the University / Institution in any regional** national or international meet, tournament, youth festival etc.
